

Eligibility Requirements

To apply for the PGY1 program, applicants must:

1. Have a Doctor of Pharmacy (PharmD) degree or equivalent from an accredited college of pharmacy.
2. Be licensed or eligible for licensure as a pharmacist in the state of Montana.

APPLICATION PROCESS | DEADLINE: FIRST FRIDAY IN JANUARY

Please submit the following items through PhORCAS.

Letter of intent describing your goals and objectives of the program and areas of interest.
Current curriculum vitae.
Official transcript from your school of pharmacy.
Three letters of recommendation.

INTERVIEW PROCESS

Interviews are offered by invitation from Residency Interview Selection Committee.
Formal presentation with PowerPoint slides required:
10 minute presentation plus 5 minute question and answer session.
Disease state, medication topic or patient case presentation with disease state.
Individual interview with preceptors.

Our pharmacists work throughout the hospital within the medical and surgical units, critical care unit, Family Birth Center, NICU and emergency department. Additionally, we operate an outpatient retail pharmacy and an ambulatory infusion center pharmacy within our Cancer Center. Clinical ambulatory pharmacy services are also provided through our Clinical Pharmacy Services (CPS) program.
